001. COMPETITION

a) Competition will take place as part of the 6. edition of Sopot Film Festival – International Independent Film Festival.

b) Competition is open for filmmakers who create their films outside of the commercial system.

c) Competition is made up of **3 sections**:

- **FULL LENGTH FEATURE – movies up to 100 min.**

- **SHORT FEATURE:**

1. Short – up to 30 min

2. Xtra Short – up to 3-4 min

3. Animation (flash, 3D, 2D, paper etc. – up to 20 min)

- **TOTAL EXPERIMENTAL:**

1. Experimental – new media, new visions etc. – up to 30 min

2. Video Art / Digital Art – up to 30 min

3. Experimental Music Video & Animation – up to 20 min

002. SUBMISSION REQUIREMENTS

a) Movies must be produced after 1. January 2003

b) Copies must be sent before **30. July 2006** to:

c) Submission package **must contain**:

- copy of film on **DVD, CD-ROM** or **VHS**

- completed and signed **entry form**

- filled e-form at: **2006.sopotfilm.com (info for festival catalogue)**

- if possible a poster and other promo stuff

d) Every film has to be recorded on a separate print.

e) Submission copy will stay after festival in organizers archive.

f) You can submit as much works as you wish, but for every submission there must be separate copy, entry form and etc. (see above).

003. COPYRIGHTS

- a) By applying films for the competition Applicant accepts the public presentation of the film at the Festival presentations and special after-festival shows promoting Sopot Film Festival.
 - b) The copyrights of the film must not be limited and must not infringe the copyrights of others. If not, the author should attach the statement specifying the legal situation of the film.
 - c) Applicant accepts broadcasting fragments of the movie (max. 1,5 min) in TV stations – partners of the Sopot Film Festival.
 - d) Fragments of selected works (max. 1,5 min) might be placed on festival website.
